

Research Master's programmes

Research Master's programmes are academic master's programmes preparing students for conducting research in a PhD trajectory or another research-related position. Apart from the regular accreditation framework, such programmes are subject to additional requirements. Research Master's programmes carry 120 ECs and are open to student selection.

GENERAL INFO

Research Master's programmes are academic master's programmes preparing students for conducting research in a PhD trajectory or another research-related position. The research orientation of the programme may be substantiated in several ways. Programmes may focus on a specific research theme or cover a wide research spectrum.

Universities are free to select students for enrolment in a Research Master's programme. Under Article 7.4a, fifth paragraph, of the Dutch Higher Education and Research Act (WHW), the statutory workload of a Research Master's programme is 120 ECs. The programmes can be identified by their name, in which the designation of the discipline is followed by "research".

Additional criteria

Research master's programmes must meet a number of additional criteria, supplementary to the regular assessment framework. These criteria pertain to the research-oriented nature of the programme and the research context within which the master's programme is being taught. During an external assessment procedure, a Research Master's programme is reviewed on the basis of the Specification of Additional Criteria for Research Master's Programmes dated 30 May 2016. The criteria are explicitly addressed in the panel report.

The additional criteria are also taken into consideration in the initial accreditation of Research Master's programmes. A university that has been granted initial accreditation of a new programme by NVAO must still apply to the Minister of Education, Culture and Science for approval of the extended statutory course duration.

Validity

The accreditation of a Research Master's programme is valid for an indefinite period of time, as is that of other master's programmes. The programme must be assessed every six years.

NVAO will process reports on the external assessment of existing Research Master's programmes within three months. Applications for the initial accreditation of a Research Master's programme will be processed within six months. NVAO decisions are open to internal and external appeal procedures.

experienced in research-oriented educational pathways. Most of the Research Master's programmes have been grouped in separate clusters.

RATES

For 2025, the NVAO rate for the assessment of an existing Research Master's programme is EUR 1,000. The rate for new Research Master's programmes is EUR 24,000.

Different rates apply for other or non-standard procedures. The costs of visits abroad, work performed by external experts, advisory work, or work associated with additional requirements will be invoiced additionally. A residual rate applies if an application for a new programme is withdrawn.

FAQ

Are all Research Master's programmes academic programmes?

Under current legislation (Article 7.4a, fifth paragraph, of the Dutch Higher Education and Research Act (WHW)), Research Master's programmes are academic master's programmes.

Are all 120-EC master's programmes Research Master's programmes?

No, only programmes for which NVAO has established their satisfaction of the requirements set for a Research Master's programme may call themselves "Research Master's programmes". On the Central Register of Higher Education Programmes (CROHO), the name of such programmes is followed by "(research)". Programmes that carry a statutory workload of 120 ECs for other reasons do not automatically qualify as Research Master's programmes.
